This Memorandum of Understanding ("MOU") is entered into by and between the PALOMAR COMMUNITY COLLEGE DISTRICT ("District") and the PALOMAR COUNCIL OF CLASSIFIED EMPLOYEES, AFT Local #4522 ("CCE"), collectively referred to as "the parties" regarding mileage for Classified employee Reyna Nievlas.

Whereas, Reyna Nievlas ("Employee") was hired as a Student Support Specialist I assigned to the Fallbrook Education Center; and

Whereas, Employee has been directed to report to the Palomar campus for training through the end of December 2023

Whereas, the District would like to compensate Employee for mileage for her commute on days she travels to Palomar for training; Therefore, the parties agree as follows:

- 1. Employee shall be reimbursed for mileage in accordance with the District travel policy for any days Employee was required to travel to the San Marcos campus for training for the period beginning with her first date of service through December 31, 2023. The mileage shall be calculated from Fallbrook Education Center to San Marcos campus.
- 2. Nothing in this MOU is intended to set precedent or establish past practice.
